## VIOLATION COMPLAINT FORM

The Master Homeowners Association for Green Valley Ranch provides this convenient form to owners/residents who wish to report alleged violations to the Association. For your protection, all complaints must be submitted in writing with adequate information. By filling out this form and returning it to the Association, action will be taken in accordance with the governing documents and the "Residential Improvement Guidelines and Site Restrictions for The Master Homeowners Association for Green Valley Ranch". Please note that the Association may already be addressing the violation.

Please be advised, the Association completes daily inspections from the street. Items that are not visible from the street or are considered mobile / temporary violations (violations that are not constantly occurring at the home: such as parking a Recreational Vehicle for periods exceeding 24 hours, issues that occur mostly on the weekends or after business hours, etc.) are generally not identified during routine inspections and need to be brought to the Association's attention.

The complainant must be willing to testify on all alleged violations that the Association is unable to verify, document and take a picture. Testimony is required if a hearing is scheduled for the purpose of determining if the alleged violation is occurring and/or during any legal proceedings. The Association is unable to guarantee confidentiality if the homeowner who receives the violation requests information on who submitted the complaint.
